**Question 2**

**Q: I would like to request an extension on the samples for this bid. FedEx has been sending out warnings that there are considerable delays nationwide. Due to weather flights are being delayed and it has been almost impossible to get the required samples in with the bid by 2/1/17.**

**Please consider accepting bids without samples and allowing additional time for all samples to be submitted.**

**A: The FY17 Promo 1 RFQ was issued on Friday, January 13, 2017; the first and only amendment was issued on Friday, January 20. Vendors interested in providing quotes for this solicitation have had 11 calendar days since the first amendment was issued to ask additional questions and send in their samples. The date and time for receiving samples remains Wednesday, February 1, 2017, at 4 p.m. Local Time.**

**Vendors should monitor the website to check for amendments and will need to acknowledge they had the opportunity to read any amendments posted when sending their quote. There are several ways to acknowledge an amendment. By identifying the amendment number and date and printing out the table 1) after the Bidding Schedule in the solicitation or 2) at the end of each amendment posted vendors acknowledge receipt of amendments. Vendors may also 3) sign and return the amendment or 4) acknowledge by letter.**
