



**FY22 GOLF PENCILS WITH NO ERASER  
REQUEST FOR QUOTES (RFQ)**

**SCOPE OF WORK**

The South Carolina Education Lottery (SCEL) is soliciting written quotes from qualified vendors to supply Golf Pencils with No Erasers as specified below. All items must be new and meet the minimum specification requirements provided herein.

**SPECIFICATION REQUIREMENTS**

2	Golf Pencil with NO Eraser	Light Green	1,002,240

**DESCRIPTION**

Golf pencils with NO erasers MUST be hex-shaped, pre-sharpened, and approximately 3 ½” in total length. Material must feature a bonded lead core and NOT be made of rainforest wood. Royal blue pencil color should match closely to PMS 286 blue and light green pencil color should match closely to PMS 361 green. Substitution in colors will NOT be accepted. All items must be deemed acceptable by SCEL.

 1-color (white) imprint  
 Text imprint only. Font style must be Sanserif (i.e. Helvetica, Arial or similar)  
 1 line with 22 characters and no spaces

Imprint Area:   Approximately 1 7/8” W x 1/8” H

**SAMPLE REQUIREMENTS FOR BID SUBMISSION\***

1. Two (2) pencil samples (Royal Blue -1; Light Green -1) are required with bid submission. Physical samples are preferred but not required. If a Bidder is unable to submit physical sample(s) prior to bid opening, then the Bidder MUST submit two (2) virtual samples (Royal Blue-1; Light Green-1).
2. Sample pencils must contain a text imprint; any color imprint is acceptable.
3. Samples MUST BE CLEARLY MARKED AND LABELED with name and address of Bidder (NOT the Manufacturer’s name). Samples which are not clearly labeled with the Bidder’s name may be deemed non-responsive.

\*All samples become SCEL property unless otherwise requested. Vendors requesting samples to be returned must indicate so on Page 5 as directed and are responsible for any associated shipping fees.

**AWARD**

Award will be made to the lowest responsible and responsive bidder.

---

**PRE-PRODUCTION PROOFS AND FINAL PRODUCTION SAMPLES**

Two (2) physical pre-production proofs (Royal Blue – 1; Light Green – 1) shall be required for SCEL approval prior to the start of final production; and four (4) physical final production samples (Royal Blue – 2; Light Green – 2) shall be required at the time the full shipment is delivered to the SCEL Warehouse. All proofs/samples must contain the required color(s) and imprint(s) and shipped to the SCEL Main Office address. Any/all costs associated with these requirements must be included in the bid price.

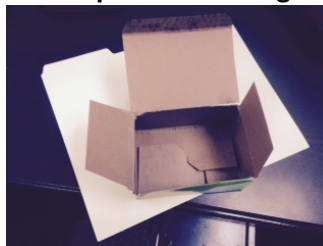

**PACKAGING**

Each box of bundled pencils (i.e. 144/box) should be designed as follows. Illustration of box design shown below is for sample purposes only.

- **Box Style:** “Snap-Bottom” Lock Box; a.k.a. “Auto-Bottom” Lock Box with a “Tuck-In Top”
- **Box Material:** Sturdy paperboard with a minimum 14 point thickness
- **Suggested Bundles:** 144 pencils per box @ 20 boxes per carton (2,880 pencils)

All boxes/cartons should contain the same color and quantity of items. Multiple colors in the same box are **not acceptable**. Cartons should not weigh more than 33 lbs. each. Contents of each carton must be clearly labeled with the item name, color, and quantity on the outside of packaging **AND** include a packing slip with description of contents to include the item name, color, quantity, and packaging specifications (i.e. how the order is bundled, grouped, and/or boxed).

**DELIVERY**

SCEL prefers to receive the order in full no later than Friday, April 22, 2022. Partial deliveries will be considered upon SCEL's approval. SCEL remains cognizant of the disruptive effects that COVID-19 continues to have on the global supply chain in the United States and abroad. We are all subject to the risk of disruption by events beyond our control and the risks associated with our reliance on imported goods from third parties. Considerations will be made to extend delivery date requirements if necessary.

Bidders may submit multiple quotes with multiple delivery transport methods (i.e. sea, air, etc.) if so desired. All items must be delivered via Freight on Board (FOB) destination and shall be delivered and unloaded onto the receiving dock with all transportation and unloading charges to be prepaid by the contractor. After Award, all deliveries and services shall be made to the "Ship To" addresses specified below.
