Action Items

a. Quarterly Advertising and Marketing Review

The Chairman stated that the quarterly advertising materials were shared with each member earlier in the week. He then asked if any member had any questions about those materials. Hearing no questions, the Chairman requested, without objection, that the minutes reflect:

b. Media Buy Plan for FY26

The Chairman recognized Josh Whiteside, Chief Marketing Officer, to answer any questions regarding the Media Buy Plan, a summary of which was shared with the members by email earlier in the week. In response to a question from Commissioner Harris, Mr. Whiteside stated that the advertising plan involved in-state advertising even though there could be some incidental carryover into border communities out of state such as Charlotte and Asheville. There being no additional questions, the Chairman entertained a motion by Commissioner Newsome, seconded by Commissioner Earle, to approve the Media Buy Plan for FY26. The motion passed unanimously.
